Market related news for the week ending July 24, 2020

- Monday the Wall Street Journal reported Chevron is close to a deal to buy Noble Energy for close to \$5 billion.
- Monday mortgage rates fell below 3% for the first time since tracking began in 1971.
- Tuesday Ebay announced it was selling its classifieds business to Norway's Adevinta for \$9.2 billion in cash and stock.
- Tuesday the Wall Street Journal reported Boeing's 737 Max may not return until 2021, because the FAA has decided to ask for public comments before finalizing software and hardware changes.
- Wednesday the U.S. State Department ordered the closure of the Chinese consulate in Houston. The U.S. dollar rose above the key 7 level against the Chinese yuan.
- Thursday Tesla stock was up on news of its fourth quarterly profit, paving the way for inclusion in the S&P500
- Friday China ordered the U.S. to close its consulate in the city of Chengdu, in retaliation for Washington forcing Beijing to leave its mission in Houston.
- Goldman Sachs agreed to a \$3.9 billion settlement with the Malaysian government Friday, over the multi-billion dollar 1MDB scandal.



Russian Trading System Cash (RTS) Index is cap-weighted composite index calculated based on prices of the 50 most liquid Russian stocks of the largest and dynamically developing Russian issuers presented on the Moscow Exchange.

S&P BSE Sensex Index is a cap-weighted index. The index members have been selected on the basis of liquidity, depth, and floating-stock-adjustment depth and industry representation.

Shanghai Stock Exchange Composite Index is a capitalization-weighted index. The index tracks the daily price performance of all A-shares and B-shares listed on the Shanghai Stock Exchange.

OAS: acronym for "option adjusted spread" which is the spread that has to be added to the Treasury yield curve in a pricing model (including embedded options) to discount a security to match its market price.
