Market related news for the week ending February 12, 2021

- Brent oil topped \$60 a barrel Monday for the first time in more than a year, on the back of supply cuts by key producers and hopes for further U.S. economic stimulus.
- Monday Tesla revealed it invested \$1.5
 billion in Bitcoin and that it expects to accept
 the cryptocurrency for payment "in the
 near future." The news sent Bitcoin surging
 past \$42,000. Meanwhile another crypto
 Ethereum, broke through \$1,800 for a new
 all-time high after its CME futures launch.
- Tuesday Electronic Arts announced it was acquiring Glu Mobile in an all-cash deal valued at \$2.1 billion.
- Twitter announced results Tuesday, reporting an increase in revenues of 28% to a record \$1.29 billion. Net income was \$222 million, up from \$119 million a year earlier.
- Wednesday almost 6,000 workers at an amazon warehouse just outside of Birmingham Alabama began a vote to unionize their facility, the first significant effort of this nature by U.S. Amazon workers.
- Dating app Bumble commenced trading on the Nasdaq Thursday. The stock was up as much as 85% in its first day of trading.
- Bitcoin was up as much as 8.1% Thursday to a record \$48,663 after Mastercard and Bank of New York Mellon Corp made moves to make it easier for customers to use cryptocurrencies.



Ibovespa Brasil Sao Paulo Stock Exchange Index is a gross total return index weighted by market value to the free float & is comprised of the most liquid stocks traded on the Sao Paulo Stock Exchange.

Russian Trading System Cash (RTS) Index is cap-weighted composite index calculated based on prices of the 50 most liquid Russian stocks of the largest and dynamically developing Russian issuers presented on the Moscow Exchange.

S&P BSE Sensex Index is a cap-weighted index. The index members have been selected on the basis of liquidity, depth, and floating-stock-adjustment depth and industry representation.

Shanghai Stock Exchange Composite Index is a capitalization-weighted index. The index tracks the daily price performance of all A-shares and B-shares listed on the Shanghai Stock Exchange.

Fixed income indices

Yield to Worst: lowest potential yield that can be received on a bond without the issuer defaulting. This yield measure takes in to account any bond calls or sinking funds.

OAS: acronym for "option adjusted spread" which is the spread that has to be added to the Treasury yield curve in a pricing model (including embedded options) to discount a security to match its market price.
