Weekly equity markets snapshot As of January 31, 2020

Market related news for the week ending January 31, 2020

- Monday saw the Dow drop more than 400 points as fears around the coronavirus hit travel stocks and the general market. The CBOE Volatility Index spiked to 19.02 intraday.
- General Motors announced Monday they would invest \$2.2 billion in Detroit to build electric vehicles.
- Apple earnings crushed analysts' expectations for the quarter Tuesday. Results were powered by iPhone sales as well as Airpods and Apple Watches. Shares hit a record high in early trading Wednesday.
- Wednesday Boeing posted its first annual loss in more than 20 years. The company said its costs from the 737 Max issue would nearly double from a previous estimate of \$19 billion.
- AMD and Xilinx fell Wednesday on weak guidance. Xilinx said it sees a slowdown in both 5G and infrastructure deployment. Meanwhile, GE shares were up 7% after beating earnings expectations.
- Wednesday L Brands shares were up 12% after the Wall Street Journal reported that founder Les Wexner is in talks to step down.
- Wednesday's FOMC meeting saw rates unchanged.
- Thursday Facebook shares fell as much as 8%, following an earnings release after the bell Wednesday that showed a 51% rise in expenses. Meanwhile Tesla and Microsoft shares were up after announcing earnings beats.
- Friday Amazon hit a \$1 trillion market cap after releasing earnings that far outstripped estimates. The company also gave upbeat guidance for the first quarter.

Economic news for the week ending January 31, 2020

- Monday: New Home Sales for December fell 0.4% to 694,000, the third straight monthly decline in sales.
- Tuesday: Durable Goods Orders for December grew 2.4%, largely due to military spending. November's reading was reduced from -2.1% to -3.1%.
- Tuesday: Case-Shiller Home Price Index for November was 3.5% year-on-year.
- Tuesday: Consumer Confidence Index for January rose to 131.6 from 126.5 in December.
- Wednesday: Pending Home Sales for December fell 4.9%, as supply of homes hit a record low in the same month.
- Thursday: Weekly Jobless Claims for week 1/25 were 216,000, for a monthly average of 214,500.
- Thursday: GDP Q4 was 2.1% quarter-over-quarter, or 2.3% year-over-year.
- Friday: Consumer Spending for December was up 0.3%
- Friday: Core PCE Price Index for December came in at 0.2%, or 1.6% year-on-year.
- Friday: Chicago PMI for January was 42.9, below expectations, and the weakest reading since late 2015.
- Friday: Consumer Sentiment Index for January was 99.8, slightly higher-than-expected.

- Monday: Markit Manufacturing PMI for January at 9.45am.
- Monday: ISM Manufacturing Index for January at 10.00am.



KOSPI Index is a capitalization-weighted index of all common shares on the Korean Stock Exchanges.

FTSE NAREIT All Eq REITS Index contains all taxqualified REITs with more than 50 percent of total assets in qualifying real estate assets other than mortgages secured by real property that also meet minimum size and liquidity criteria.

FTSE 100 Index is a capitalization-weighted index of the 100 most highly capitalized companies traded on the London Stock Exchange. The equities use an investibility weighting in the index calculation.

Russian Trading System Cash (RTS) Index is cap-weighted composite index calculated based on prices of the 50 most liquid Russian stocks of the largest and dynamically developing Russian issuers presented on the Moscow Exchange.

S&P BSE Sensex Index is a cap-weighted index. The index members have been selected on the basis of liquidity, depth, and floating-stock-adjustment depth and industry representation.

Shanghai Stock Exchange Composite Index is a capitalization-weighted index. The index tracks the daily price performance of all A-shares and B-shares listed on the Shanghai Stock Exchange.

Yield to Worst: lowest potential yield that can be received on a bond without the issuer defaulting. This yield measure takes in to account any bond calls or sinking funds.

OAS: acronym for "option adjusted spread" which is the spread that has to be added to the Treasury yield curve in a pricing model (including embedded options) to discount a security to match its market price.
